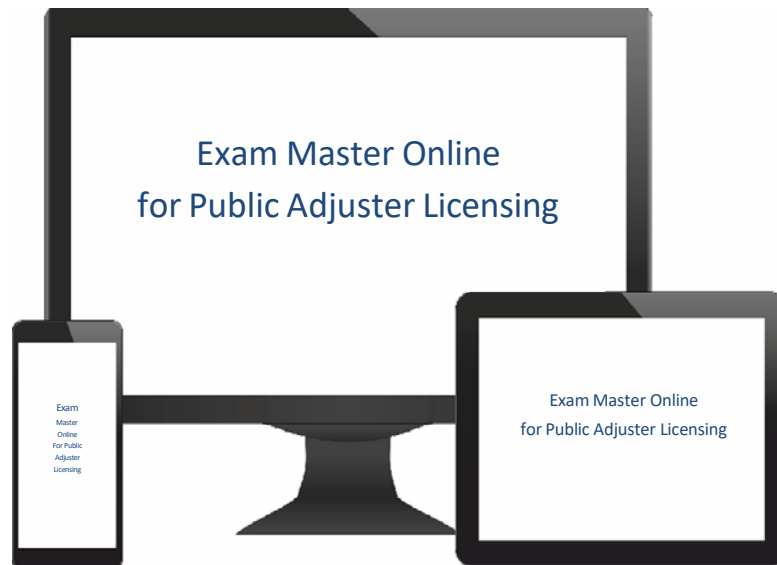
**Pennsylvania Public Adjuster Licensing** – Individuals seeking a Pennsylvania public adjuster’s license must score at least 70% or higher on the Pennsylvania Public Adjuster’s (series 16-19) examination. The exam consists of 60 multiple-choice questions. The exam addresses the following subjects: Insurance Regulations, General Insurance, Property and Casualty Insurance Basics, Dwelling Policy, Homeowners Policy, Commercial Property Policies, Commercial Inland Marine, Businessowners Policy, Other Types of Insurance Policies, and the Adjustment Process.
